Executive Director (ED) Position Available

Rapid Resource for Families (RRFF) is a non-profit agency responsible for the administration of Intensive Alternative Family Treatment (IAFT)[®], an intensive therapeutic foster care service for children and youth in challenging circumstances. RRFF, is responsible for credentialing and networking with service providers for the provision of the service, the development and maintenance of program monitoring, accountability, and promotion. RRFF is also responsible for overseeing and assuring implementation of an information system to receive intake or request for placement of children and youth into Therapeutic Foster Care (TFC) services across a collaborative network of child and youth behavioral health treatment agencies in North Carolina.

The position reports to the RRFF Board of Directors. The position is responsible for the recruitment, training, and supervision of three to five staff. The position must develop, negotiate, and monitor multiple contractual relationships with the Medicaid health plan and other entities that may provide contractual services required in the day-to-day operations of RRFF. This includes examples such as web site maintenance, data base development and maintenance and universities conducting research studies.

EDUCATION, KNOWLEDGE AND SKIILLS REQUIRED

Education: Fully accredited Masters' Degree in Human Services with at least two (2) years senior management experience.

The position must demonstrate ability to lead an agency, setting strategic direction and maintaining policies and procedures to support the ongoing compliance with the integrity of the service and support requested by the Medicaid health plans.
